FEE AUDITOR'S FINAL REPORT REGARDING SECOND INTERIM QUARTERLY FEE REQUEST OF PETER J. SOLOMON COMPANY

Direct Fee Review LLC ("DFR"), appointed and employed as the Fee Auditor in the above-captioned bankruptcy proceedings and acting in its capacity regarding the Second Interim Fee Request of Peter J. Solomon Company for compensation for services rendered and reimbursement of expenses as investment banker and financial advisor to the Debtors and Debtors-in-Possession for the period September 1, 2009 through November 30, 2009 ("Fee Request") seeking approval of fees in the amount of \$600,000.00 and reimbursement of expenses in the amount of \$40,698.50, submits its final report related to the reimbursement of expenses.

BACKGROUND

In performance of audit procedures and in preparation of this report designed to quantify and present factual data relevant to the requested disbursements and expenses contained herein, DFR reviewed the monthly fee statements and the Fee Requests, including each of the expense entries listed in the exhibits to the monthly statements, for compliance with 11 U.S.C. § 330, Rule 2016-2 of the Local Rules of the United States Bankruptcy Court for the District of Delaware, as amended February 1, 2009 ("Local Rules"), and the United States Trustee Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed Under 11 U.S.C. § 330, issued January 30, 1996 ("Guidelines").

DISCUSSION

For the compensation period of September 1, 2009 through November 30, 2009 Peter J. Solomon

The Debtors, along with the last four digits of each Debtor's tax identification number, are as follows: Building Materials Holding Corporation (4269), BMC West Corporation (0454), SelectBuild Construction, Inc. (1340), SelectBuild Northern California, Inc. (7579), Illinois Framing, Inc. (4451), C Construction, Inc. (8206), TWF Construction, Inc. (3334), H.N.R. Framing Systems, Inc. (4329), SelectBuild Southern California, Inc. (9378), SelectBuild Nevada, Inc. (8912), SelectBuild Arizona, LLC (0036), and SelectBuild Illinois, LLC (0792). The mailing address for the Debtors is 720 Park Boulevard, Suite 200, Boise, Idaho 83712.

Company submitted monthly fee applications in the amount of \$600,000.00 as actual, reasonable and necessary and reimbursement of expenses in the amount of \$40,698.50. For the Fee Request period \$0 was charged for fee applications.

- 1. DFR noted charges of costs which appear to be excessive. These items are listed in Exhibit A. We requested that the firm review the charges to confirm economy class rates or provide an explanation of the fare. After discussions with the firm and additional information provided by the firm, the firm agreed that one of the fares was not economical and we recommend that expenses be reduced by \$1,246.00. The firm has agreed to reduce charges by \$1,246.00 for this fare.
- 2. Based upon a review for reasonableness DFR noted the entry listed in Exhibit B which may be considered excessive. In general DFR deems charges in excess of \$15/\$25/\$50 for breakfast/lunch/dinner to be not reasonable. After discussions with the firm we recommend that expenses be reduced by \$225.44. The firm has agreed to reduce charges by \$225.44 for these entries.
- 3. Based upon a review for reasonableness we have noted the taxi expense entries listed in Exhibit C exceed the normal fixed charge of \$45 between JFK and New York City. We requested the firm provide additional information related to these charges which will explain the difference. The firm responded that "these trips were completed using black car service, not standard yellow taxi service, because of the location of the fare". After discussions with the firm and additional information provided by the firm we do not recommend any change for these entries.
- **4.** Also, we noted the charges listed in Exhibit D and E and requested information related to the charges. After discussions with the firm and additional information provided by the firm we do not recommend any change for these entries.
- 5. Based upon a review of timekeepers fee charges DFR noted the entries listed in Exhibit F which may be considered as part of a general administrative compensation program that is factor considered in establishing the firm's compensation rate and not actual, necessary or reasonable charges to the estate. We requested that the firm review the entries and provide an explanation for these charges. The firm responded that "Ben Berg is an analyst who joined the firm recently and supported our work on BMHC through various administrative and basic analytical tasks. We did not separately record his hours however we have recorded his meals in proportion to the amount of his time he spent on BMHC. Since all professionals work on multiple projects meal expenses for Brad, Paul C and Paul G are billed to BMHC roughly in proportion to the percentage of total time that we each spent on BMHC relative to other projects we work on." After review of retention documents and the response; we do not recommend that expenses be reduced for these amounts.

CONCLUSION

Regarding the Second Interim Fee Request and the expenses discussed in the previous

sections, DFR will submit its report for the Second Interim Fee Request of Peter J. Solomon Company as investment banker and financial advisor to the Debtors and Debtors-in-Possession for reimbursement of expenses for the Period from September 1, 2009 through November 30, 2009 and we recommend the approval of the reimbursement of expenses net of adjustments identified above in the amount of \$39,227.06 (\$40,698.50 minus \$1,471.44).
