Thereafter, Resinart Corporation ("Resinart") and W&F Manufacturing, Inc. ("W&F," and together with the Reorganized Debtors and Resinart, the "Parties") each filed a response (collectively, the "Responses") to the Claims Objection. The Parties have worked together to resolve the Responses and have done so through the Proposed Order (as defined below).

Attached hereto as <u>Exhibit 1</u> is a proposed form of order (the "<u>Proposed Order</u>") for the Claims Objection solely as it pertains to Resinart and W&F.² The Reorganized Debtors

ORDERED, ADJUDGED AND DECREED that:

- 1. The Objection is sustained to the extent provided for herein.
- 2. Nothing in this Order is intended or shall be deemed to amend, modify or otherwise affect that certain (i) Order Sustaining, In Part, Debtors' First Omnibus (Non-Substantive) Objection to Claims Pursuant to Section 502(b) of the Bankruptcy Code,
 Bankruptcy Rules 3003 and 3007 and Local Rule 3007-1 [Docket No. 967] (the "First Order") and (ii) Second Order Sustaining, In Part, Debtors' First Omnibus (Non-Substantive) Objection to Claims Pursuant to Section 502(b) of the Bankruptcy Code, Bankruptcy Rules 3003 and 3007 and Local Rule 3007-1 [Docket No. 1279] (together with the First Order, the "Prior Orders"), and the Prior Orders shall remain in full force and effect.
- 3. Claim Number 2620 (the "Resinart Proof of Claim") filed by Resinart Corporation ("Resinart") is hereby deemed timely filed and no other action needs to be taken by Resinart with respect to the filing of the Resinart Proof of Claim.
- 4. Pursuant to section 502(b) of the Bankruptcy Code, Bankruptcy Rules 3003 and 3007 and Local Rule 3007-1, the Resinart Proof of Claim is hereby reassigned to Case No. 09-12075 and Debtor BMC West Corporation ("BMC West") and shall be deemed to supersede and replace in its entirety Resinart's scheduled claim against BMC West. On account of the Resinart Proof of Claim, Resinart shall have: (i) an allowed administrative expense claim in the amount of \$7,000.00 under section 503(b)(9) of the Bankruptcy Code (the "Resinart 503(b)(9) Claim"); and (ii) an allowed general unsecured claim in the amount of \$5,290.92 (the

"Resinart General Unsecured Claim"). The Resinart 503(b)(9) Claim and the Resinart General Unsecured Claim shall be treated in accordance with the provisions of that certain Joint Plan of Reorganization for the Debtors Under Chapter 11 of the Bankruptcy Code Amended December 14, 2009 (With Technical Modifications) (the "Plan").

- 5. Claim Numbers 2614 and 2615 (together, the "<u>W&F Proofs of Claim</u>") filed by W&F Manufacturing, Inc. ("<u>W&F</u>") are hereby deemed timely filed and no other action needs to be taken by W&F with respect to the filing of the W&F Proofs of Claim.
- 6. Pursuant to section 502(b) of the Bankruptcy Code, Bankruptcy Rules 3003 and 3007 and Local Rule 3007-1, on account of the W&F Proofs of Claim, W&F shall have an allowed administrative expense claim in the aggregate amount of \$225.00 under section 503(b)(9) of the Bankruptcy Code (the "<u>W&F 503(b)(9) Claim</u>"). The W&F 503(b)(9) Claim shall be treated in accordance with the provisions of the Plan.
- 7. The Resinart 503(b)(9) Claim and the W&F 503(b)(9) Claim granted herein shall be binding on the Debtors, the Debtors' estates and any successors to the Debtors.
- 8. The Debtors' claims and noticing shall mark the Resinart Proof of Claim and the W&F Proofs of Claim in accordance with the provisions of this Order.
- 9. The Debtors (and any successors or successors in interest) reserve any and all rights to amend, modify or supplement the Objection, and to file additional objections to any and all claims filed in these chapter 11 cases, including, without limitation, any and all claims that are the subject of the Objection.
- 10. The Debtors (and any successors or successors in interest) reserve any and all rights to object to any and all of the Disputed Claims on any and all grounds in any and all additional objections to claims filed in these chapter 11 cases.

11. This Court shall retain jurisdiction over any and all affected parties with respect to any and all matters, claims or rights arising from or related to the implementation or interpretation of this Order.
