FOURTH NOTICE OF CLAIMS 12 PREVIOUSLY SATISFIED [Docket No. 1433] 13 14 Maricopa County, a secured tax lien creditor, by and through its undersigned 15 counsel, hereby objects to Debtors' Fourth Notice of Claims Previously Satisfied (the 16 "Notice"). 17 Maricopa County submitted for filing its Proof of Claim dated September 24, 2009 18 in the amount of \$68,302.02 representing the unpaid business personal property taxes 19 for tax year 2009 on Parcels 901-11-467, 905-67-849 and 910-42-954. The taxes are 20 secured liens that are "prior and superior to all other liens and encumbrances on the 21 property." See, A.R.S. § 42-17153. Interest accrues on the afore-mentioned secured 22 tax claims at the statutory rate of 16% per annum, if not timely paid. See, 11 U.S.C. § 23 511 and A.R.S. § 42-18053. 24 Maricopa County objects to the Notice as only a portion of the secured taxes 25

1 have been paid. Debtors indicate that Maricopa County's claim was satisfied by a 2 payment from Chicago Title on January 4, 2010. Maricopa County's records include 3 check #9600004529 in the amount of \$34,813.93 dated January 12, 2010 was received 4 from BMHC. The amounts received only paid approximately the first half of the 2009 5 personal property taxes, but did not cover all the accrued interest. Interest accrues from 6 the Petition Date at the statutory rate of 16% per annum in accordance with 11 U.S.C. § 7 511 and A.R.S. § 42-18053. 8 Based on the foregoing, Maricopa County objects to the Notice and respectfully 9 requests that the Court deny approval of the Notice with respect to Maricopa County's 10 Secured Tax Claims as the taxes included in Maricopa County's secured claim have not 11 been satisfied.
