COMMONWEALTH OF VIRGINIA DEPARTMENT OF TAXATION'S RESPONSE TO FIFTEENTH OMNIBUS OBJECTION TO CLAIMS

COMES NOW the Commonwealth of Virginia, Department of Taxation ("the Department"), by counsel, and files this Response to the Debtor's Omnibus Objection to Claims and in support thereof states as follows:

- 1. The Department filed two claims in this consolidated case which are both subject to this objection. The first (denominated #2810) is an estimated claim for corporate income taxes for Building Materials Holding Corp for 2005 through 2008. The second (denominated #2811) is an estimated claim for corporate income taxes for BMC West for 2006 through 2008.
- 2. The Debtor objects to these claims asserting that there is no taxable nexus with Virginia and therefore there is no liability.
- 3. The Debtor, Building Materials Holding Corp, however, has previously filed corporate income tax returns with the Virginia Department of Taxation, including for tax years 2006, 2007 and 2008. The debtor has also paid corporate income taxes to Virginia in 2006 and 2007.
- 4. The Debtor, BMC West, has failed to file corporate income tax returns with the Virginia Department of Taxation for tax years 2006 through 2008 despite having registered to do so.
- 5. The filing and payment history of this debtor belies their argument and the Department of Taxation demands that the missing returns be filed so that the actual liability of the debtor can be determined.
