**CERTIFICATION OF COUNSEL REGARDING DEBTORS' SIXTH OMNIBUS MOTION
FOR AN ORDER AUTHORIZING REJECTION OF CERTAIN UNEXPIRED LEASES AND
EXECUTORY CONTRACTS, NUNC PRO TUNC TO THE REJECTION EFFECTIVE DATE**

On July 10, 2009, the above-captioned debtors and debtors-in-possession (collectively, the “Debtors”) filed the Debtors’ Sixth Omnibus Motion for an Order Authorizing Rejection of Certain Unexpired Leases and Executory Contracts, *Nunc Pro Tunc* to the Rejection Effective Date [Docket No. 157] (the “Motion”). Subsequent to the filing of the Motion, the Debtors determined that it was necessary to remove from the Motion that certain lease (the “Toshiba Lease”) with Toshiba Financial Services/Zoom Imaging Solutions, Inc. (“Toshiba”), dated September 11, 2006, and Toshiba has consented to the Debtors doing so.

In light of the foregoing, attached hereto as Exhibit A is a revised proposed form of order (the “Revised Proposed Order”) for the Motion, which has been modified to remove the Toshiba Lease and note the entry of that certain Order Pursuant to Sections 501, 502, and 1111(a) of the Bankruptcy Code, Bankruptcy Rules 2002 and 3003(c)(3), and Local Rule 2002-1(e) Establishing Bar Dates for Filings Proofs of Claim and Approving the Form and Manner of



**SIXTH ORDER AUTHORIZING THE DEBTORS TO
REJECT CERTAIN UNEXPIRED LEASES AND EXECUTORY
CONTRACTS, NUNC PRO TUNC TO THE REJECTION EFFECTIVE DATE**

Upon consideration of the sixth omnibus motion (the "**Motion**") of Building Materials Holding Corporation and its affiliates, as debtors and debtors in possession (collectively, the "**Debtors**") for entry of an order authorizing the Debtors to reject certain unexpired leases, as set forth in the Motion; and the Court having found that venue of this proceeding and the Motion in this district is proper pursuant to 28 U.S.C. sections 1408 and 1409; and the Court having found that the relief requested in the Motion is in the best interests of the Debtors' estates, their creditors, and other parties in interest; and notice of the Motion and the opportunity for a hearing on the Motion was appropriate under the particular circumstances; and the Court having reviewed the Motion and determined that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and upon all of the proceedings had before the Court; and after due deliberation and sufficient cause appearing therefor,

1. The Motion is granted as set forth below.
2. Pursuant to section 365(a) of the Bankruptcy Code, the Debtors are authorized to reject the Personal Property Leases² listed in ***Exhibit A*** annexed hereto. Effective immediately, such Personal Property Leases are deemed rejected (the "***Rejections***"), with the Rejections being effective as of July 10, 2009 (the "***Rejection Effective Date***").
3. The Counterparties to the Personal Property Leases shall have until the date fixed by this Court pursuant to that certain Order Pursuant to Sections 501, 502, and 1111(a) of the Bankruptcy Code, Bankruptcy Rules 2002 and 3003(c)(3), and Local Rule 2002-1(e) Establishing Bar Dates for Filings Proofs of Claim and Approving the Form and Manner of Notice Thereof [Docket No. 248] to file any claim for damages arising from rejection of a Personal Property Lease.
4. The Debtors are authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Motion.
5. The Debtors do not waive any claims they may have against the Counterparties to the Personal Property Leases, whether or not such claims arise under, are related to the rejection of, or are independent of the Personal Property Leases.
6. Nothing herein shall prejudice the rights of the Debtors to argue that any claim for damages arising from the rejection of the Personal Property Leases is limited to the remedies available under any applicable termination provision of such Personal Property Lease, or that any such claim is an obligation of a third party, and not that of the Debtors or their estates.
