VERIFIED STATEMENTS OF CONNECTIONS

- I, David L. Osborn, declare under penalty of perjury:
- 1. I am the sole attorney of The Osborn Law Firm, LLC, located at 217 West Olive, Fort Collins, CO 80521 (the "Firm").
- 2. Building Materials Holding Corporation and its affiliates, as debtors and debtors in possession (collectively, the "Debtors") have requested that the Firm provide collection services to the Debtors, and the Firm has consented to provide such services.
- 3. If the Firm is a law firm, I state that the Firm did represent the Debtors prior to their bankruptcy filings.
- 4. The Firm may have performed services in the past, may currently perform services and may perform services in the future, in matters unrelated to these chapter 11 cases, for persons that are parties in interest in these chapter 11 cases. The Firm does not perform services for any such person in connection with these chapter 11 cases, or have any relationship with any such person, their attorneys or accountants that would be adverse to the Debtors or their estates. - 6. Neither I nor any principal, partner, director, officer, etc. of, or professional employed by, the Firm has agreed to share or will share any portion of the compensation to be received from the Debtors with any other person other than the principal and regular employees of the Firm.
- 7. In the ordinary course of its business, the Firm confirms conflicts by reviewing its client base. The Firm's database contains information regarding the Firm's present and past representations. Pursuant to Federal Rule of Bankruptcy Procedure 2014(a), I obtained a list of the entities identified in Rule 2014(a) from counsel to the Debtors for purposes of searching the aforesaid database and determining the connection(s) which the Firm has with such entities. Neither I nor any of the professionals employed by, the Firm, insofar as I have been able to ascertain, holds or represents any interest adverse to the Debtors or their estates with respect to the matters(s) upon which this Firm is to be employed. Furthermore, if the Firm is either (i) not a law firm or (ii) a law firm that did not represent the Debtors prior to their bankruptcy filings, I state that neither I nor any of the professionals employed by, the Firm, insofar as I have been able to ascertain, holds or represents any interest adverse to the Debtors.
